5 **Call to Order**

6 Chair Terranova called the meeting to order. (3:01 p.m. ET)

7

8 **Roll Call**

9 J. Thomas called roll. 7/7 members present, establishing quorum.

10

11 **Review and Adopt Agenda**

12

13 **Motion:**

- 14 • Elizabeth Huntley motions to adopt the agenda
- 15 • Jamie Alley second.
- 16 • All members voted in favor; none abstained; motion passed.

17

18 **Review and Approve Draft Minutes**

19 Committee reviews minutes and recommends changes, clarifying AI policy.

20

21 **Motion:**

- 22 • Jamie Alley motions to approve the minutes as amended.
- 23 • Larry Marx second.
- 24 • All members present voted in favor; none abstained; motion passed.

25

26 **Legislative Update**

- 27 • Carl Sims provides legislative update.
  - 28 ○ Legislation still active in Michigan, New Jersey, and North Carolina.
  - 29 ○ 2025 Likely legislation – AR, IA, CT, KS, ND, NV, OR, RI, TX
  - 30 ○ 2025 Maybe legislation – IL, MO, PA, VT
  - 31 ○ Have already worked bill review for Arkansas and Nevada for 2025
- 32 • CSG providing legislative support including legislative tracking, bill reviews, education and
- 33 legislative testimony. AAPA providing support for state professional association chapters on
- 34 legislative efforts.

36 **Future Meetings**

- 37 • Rules Committee - Chair Terranova shares that Rules Chair Stephanie Loucka believes an in-
- 38 person rules committee meeting would be beneficial.
  - 39 ○ Chair Terranova shares that Lisa Robin from FSMB indicated there were funds for travel.
  - 40 ○ Options to host it at the FSMB office in D.C. or at Chair Loucka’s Columbus office in
  - 41 Ohio.
  - 42 ○ Likely 3<sup>rd</sup> or 4<sup>th</sup> week of January.
  - 43 ○ Committee is in agreement that an in-person rules committee meeting is a good idea.
- 44 • Full Commission - Chair Terranova leads discussion about a full commission meeting in April.
  - 45 ○ FSMB offered space and tech at the meeting in Seattle. Many delegates will already be
  - 46 there.
  - 47 ○ E. Huntley notes Administrators in Medicine (AIM) is aligned with FSMB already, some
  - 48 may have commitments to that.

- 49 ○ Meeting would not need to be a full day, a few hours during a sunrise session would be
- 50 sufficient.
- 51 ○ Travel funding for those not already going to FSMB would be preferred but to be
- 52 decided depending on funds. There will be a virtual option.

53

54 **Motion:**

- 55 ● Larry Marx motions to hold the annual PA Compact Commission business meeting in
- 56 conjunction with FSMB in April 2025, delegating final date and time to chair.
- 57 ● Marisa Courtney second.
- 58 ● All members voted in favor; none abstained; motion passed.

61 **Committee Reports**

- 62 ● Finance – L. Marx shares that the finance committee drafted a budget.
- 63 ○ \$150,000 commitment from AAPA
- 64 ○ Fiscal year recommendation of Oct 1 – Sep 30

65

66 **Draft Budget**

- 67 ● L. Marx goes over budget and explains these are estimates.
- 68 ● C. Sims provides further details about costs
  - 69 ○ CSG interim executive director and secretariat costs will be less than what is reflected in
  - 70 the draft budget. The draft budget projects the costs for contracted executive director
  - 71 and secretariat services after CSG’s interim services concludes. The cost of CSG services
  - 72 are for time and materials accrued. Contracted executive director and secretariat
  - 73 services are expected to be fixed fee.
  - 74 ○ The cost of legislative services provided by CSG are for time and materials accrued and
  - 75 are not charged as a fixed fee.
  - 76 ○ Data system costs represent starting funds.
- 77 ● G. Thomas shares that NCCPA is also expected to formally commit \$150,000 to the PA Compact
- 78 Commission in February. Clarifies that there will be separate MOUs between NCCPA/CSG and
- 79 AAPA/CSG to provide services prior to selecting a secretariat.
- 80 ● J. Hepner asks, how have other compacts addressed revenue?
  - 81 ○ L. Marx – There will be fees and costs associated with buying a compact privilege. For
  - 82 example, IMLC charges for using the compact, one they keep one goes to the state.
  - 83 ○ N. Kalfas – This is a proposed draft budget which will be consistently revised.
  - 84 ○ G. Thomas – NCCPA has discussed the \$150,000 but the board anticipates more funds
  - 85 will be needed in the future.

87 **Motion:**

- 88 ● J. Alley motions to accept/approve preliminary draft budget.
- 89 ● L. Marx seconds.
- 90 ● All members voted in favor; none abstained; motion passed.

91

92 **Fiscal Year**

- 93 • Finance committee recommends a fiscal year of Oct. 1 – Sep. 30. L. Marx explains reasoning that  
94 it allows states on a July 1- June 30 fiscal year to prepare for staffing, legislative mandates, etc.  
95 • Chair Terranova points out that in this case states would not be able to provide funds to the  
96 commission until after July 1<sup>st</sup>  
97 • Fiscal year is discussed including flexibility of setting state fees (if later adopted) and holding  
98 virtual meetings. N. Kalfas confirms that the commission can set the schedule for state fees.

101 **Motion:**

- 102 • L. Marx motions to accept a fiscal year of October 1 – September 30.  
103 • E. Huntley seconds.  
104 • All members voted in favor; none abstained; motion passed.  
105

106 **Written request for funds FSMB**

- 107 • Chair Terranova shares that FSMB Foundation representatives indicated they had funds and  
108 recommended the PA Compact Commission write for a grant.  
109 • Discussion over the grant. General agreement that the Commission should apply for funds.  
110

111 **Motion**

- 112 • L. Marx motions to apply for grant funds from FSMB Foundation.  
113 • M. Courtney seconds.  
114 • All members voted in favor; none abstained; motion passed.  
115

116 Chair Terranova will put together a draft for the grant application.  
117

118 **New Delegate Handbook**

- 119 • Chair Terranova shared that Jean Fischer agreed to chair the Communications Committee.  
120 • Chair Terranova will advise her to make a handbook for new delegates a priority for the  
121 Communications Committee.  
122 • N. Kalfas gives example from Counseling Compact of a compilation of governance documents  
123 (bylaws, other policies, rulemaking, etc) that properly refer to each other where needed and  
124 that each document cites where in the compact their authority draws from.  
125

126 **Delegate Questions and Comments**

- 127 • Can a copy of the AI policy be provided?  
128 ○ Directed to AI Policy final document on the website, located with Nov. 13 Executive  
129 Committee materials.  
130 • When would insurance be purchased?  
131 ○ N. Kalfas – As soon as possible, before compact is operationalized. Need a bank account  
132 to purchase it out of.  
133 ○ C. Sims – Could explore if CSG is able to purchase that before there is a bank account  
134 established by the contracted secretariat.  
135 ○ Insurance information requested before next Executive Committee meeting.
