58	What do the highlighted cells mean? We don't have enough information yet to fill them.
59	What type of calendar is this? Using the federal fiscal year for this example but the executive committee
60	will need to set a fiscal year for the compact commission.
61	
62	L. Marx summarizes some future steps including identifying processes needed, software needed. Calls
63	for a meeting to settle some of this information and send the proposed draft budget to executive
64	committee, preferably in December so that the budget can be sent to funders.
